REGISTRATION OF GOLF CAR VEHICLES (GOLF CARTS) UTILITY TYPE VEHICLES AND ALL-TERRAIN VEHICLES WITH THE CITY OF WILBER.

The City of Wilber has passed ordinances pertaining to the registration of Golf Car Vehicles (Golf Carts), Utility Type Vehicles and All-Terrain Vehicles with the Wilber City Office. Owners will need to complete a short permit application form and provide the following information. 1) Make, model, year and V.I.N. of the vehicle. 2) Proof of Liability Insurance as required by Nebraska Law. 3) Attach to the rear of the vehicle a not less than 30 square inch triangular shaped day-glow safety flag that extends not less than 5 feet above ground. 4) Pay an annual registration fee of \$25. Once the owner provides all the required information they will be issued a sticker for their vehicle which needs to be affixed to the driver's side of the unit. Any person operating a Golf Cart, UTV or ATV as authorized shall have a valid Class "O" motor vehicle operator's license issued by the Nebraska Department of Motor Vehicles and shall be of an age of seventeen (17) years or older.
